Sealed Bids for the construction of the McKenney Tank Painting Rehabilitation will be received by the Dinwiddie County Water Authority (DCWA), at the office of the Dinwiddie County Water Authority (DCWA), until 2:00 PM local time on February 26, 2019, at which time the Bids received will be opened and read. The Project consists of removing and recoating the interior and exterior of a 100,000-gallon elevated steel water tank and the replacement of other related tank and site appurtenances.

Bids will be received for a single prime Contract. Bids shall be on a lump sum and unit price basis, with additive alternative bid items as indicated in the Bid Form.
